Fees for Hair Transplant Surgery

Dr. Marcelo Gandelman

By the Area and By the Hour

I am commenting on your article, *Minigrafts Cause Maxi–* Fees, from HAIR TRANSPLANT FORUM, Volume 2, Number 2.

When I charged by the graft, I felt tied to the fee previously agreed upon with the patient. If the estimated number of punches proved to be insufficient, I had to do more without additional charge. If my estimate proved to be too high, I had to do fewer grafts and reduce my fee.

For eight years now, I have been charging by the area grafted and the time consumed in one session. The charge is independent of the kind of graft (mini, quad, large graft, etc.).

This policy puts me more at

ease during surgery.

Besides, patients are not well acquainted with the different techniques and the skill required. They do not know that you are charging more for micros because you work harder on them.

The only thing the patient can evaluate is the fact that his friend, who recommended you, has had the same operation; and he expects the same fee.

Despite these considerations, I do not have a standard fee. Since making micros involves more time, I believe that charging by the area and by time consumed is a clear and honest way to set and explain fees to the patient.

Dr. Sheldon Kabaker By the Session

I have begun charging by the session, which I describe as abbreviated, regular, or extended. I tell the patient that each session consists of a minimum of 50, 100 or 150 grafts, respectively.

The breakdown of circular grafts to mini-grafts to mini-grafts to minigrafts varies from one patient to another, but the total number of grafts always exceeds the minimum number.

I am not quite satisfied with this system, or with the ease of explaining it to patients, especially when their reference is to charges by the graft.

I look forward to reading the ideas of others in the FORUM.
